Dear Sir/Madam,

Submission of Statutory Auditor Certificate for Premium Paid to DICGC

As you are aware, Statutory Auditors appointed by banks are required to certify premium paid on the Assessable Deposits of both half years i.e. Half Year ending September (April-September), deposit base for which is 31st March and Half Year ending March (October-March), deposit base for which is 30th September. In this regard, a reference is drawn to DICGC circulars, viz. (i) DICGC/9943 /05.60.999/2011-2012 dated September 21, 2011 and (ii) DICGC/IOD/4413/05.60.999/2017-2018 dated June 02, 2017, on the captioned subject (available at website www.dicgc.org.in).

- 2. It is observed that the Statutory Auditor Certificate is not submitted or is being submitted with inordinate delay. Timely and correct validation of Assessable Deposits obviates errors in classification of Assessable Deposits as per extant guidelines and computation of premium. Instances have been observed of wrong classification and premium payout.
- 3. We reiterate instructions contained in our above circulars and advise banks to ensure submission of Statutory Auditor Certificate by June 30th of the financial year in progress for both previous half years. Prescribed format is attached herewith once again for ready reference.
- All member banks of DICGC are advised to ensure compliance.
